• 2017/18 Mayoral report

Councillors it has been a privilege to serve as Mayor of Swan Hill Rural City Council.

Work on Nyah Road, Swan Hill has continued into a full reconstruction which was a \$2 million dollar project that started in May 2017 and it is thanks to the Federal Government Roads to Recovery project.

Another significant event this year was the 100th Anniversary of the batlle of Villers-Bretonneux which was held in Robinvale in April this year. The community banded together to commemorate the battle and the 100 year relationship with Villers-Bretonneux, France. The event included an official opening at the Robinvale/Euston Memorial Park, a Euston cenotaph re-consecration , RSL service and a community barbecue which was well represented. The Robinvale community are to be congratulated for the effort that they put into that and the on-going effort that they put into the sister city relationship.

A \$500,000 refurbishment funded by the Victorian Government's Living Heritage Program has breathed new life into the PS Gem. The project was completed in June, and included improving the condition of the vessel's hull and reducing leakage by recaulking the vessel and tightening up the butts and joins.

Also at the Pioneer Settlement, we launched the Hometown Hero program which is a great success.

We are becoming an Australian leader in solar energy generation. This past year saw us take some major steps forward. The Swan Hill solar farm was completed, and work continued to build large solar farms at Bannerton and Wemen they are 100 megawatts so we are talking 300,000 panels. We were especially pleased to see that the Bannerton solar farm will be one of two in Victoria to power the Yarra Tram network in Melbourne – Mallee sun powering city trams!

This year we had the successful launch of the Lake Boga Catalina Café. The building was completed and leased, a great addition to Lake Boga and to our region's liveability and tourism offering and you are lucky to get a seat when you go there for coffee. It's a great asset to our region.

Also we have worked with the Robinvale District Health Service to return Maternal and Child Health Services to Robinvale.

We also started a pro-active campaign to stamp out illegal rooming houses in Robinvale; and obtained funding to build the Robinvale town levee. Which I'm sure Councillor Katis has been arguing for many years about the levee and he would be very grateful of that. I didn't see him do cartwheels down the main street.

The redevelopment of our saleyards has also just commenced after a lot of community consultation we have got that right. It's a great project into the future.

Planning for the future has been a big part of our work this year as well. Council adopted plans for local recreation reserves, community access and inclusion, Aboriginal partnerships, creative strategy, economic development and public health, just to name a few.

There's also the work on Robinvale Early Learning Centre and Library which will be open for the start of the 2019 school year.

Advocacy

The year the Murray River Group of Councils is one advocacy group that we work strongly with. It's a great group respected by both State and Federal Politicians We've been involved in the lobbying for the Swan Hill Needs a New Hospital Campaign and we are still lobbying to get Labour to come on board (we have still got time).

And obviously there is countless hours on the road with not only trips to Melbourne but trips to Canberra as well talking to Federal and State politicians.

Funding success

We've had a great deal of funding success over the last year

Riverfront Connection and Active Pay precinct

Funding for the Gallery designs

Regional Growth Fund progress – I think Heather Green (Director of Infrastructure) and her team should be congratulated for the regional growth fund the work they put into that on a regional basis involving seven councils, just on \$16 million dollars so

it's a great effort and a great amount of work done by the staff. I appreciated that Heather as I'm sure all of the Councillors do.

Fixing Country Roads - \$700,000 to fix the roads throughout the Municipality.

Lake Boga Preschool funding - the State Government announced \$340,000 to allow Council to undertake a significant upgrade of the Lake Boga Education Hub. Funding will include upgrades to the pre-school and the creation of an early learning consulting room for use by Maternal and Child Health nurses and other early years intervention specialists.

Most recently we've received an election commitment for the Lake Boga Swan Hill Trail

And finally, it was really touching that my last official duty as a mayor was laying a wreath at the Swan Hill Cenotaph for Remembrance Day. Celebrating the 100 years since armistice, it was a terrific event and great to see so many young children there.

And while I have the floor Mr CEO, everyone is aware that I will not be standing for the mayor's position this year and I would like to thank my fellow councillors for their support. To the Executive Leadership team, Mr CEO thank you very much for your support I think that we do work very well collaboratively as a team and I think that's what makes Swan Hill great. We can take different viewpoints and respect each other's view points and move on and I think that's a great thing we have here. You look a nearby council's and there's a lot of issues in the end because a lot of Councillors fight amongst themselves. We have a great Council here which assists in making this a great place to live and work.

In my final Mayoral Column I did mention the three girls that help the Mayor considerably in the Council, our minutes secretary Sharon Lindsay, our media department Felicia Chalmers and Makayla Rust thank you very much for your support throughout the time as mayor it's greatly appreciated.

I wish the new incoming mayor all the best (whoever that may be) and I will offer my support to that person whoever that will be, as I'm sure all Councillors will. I think if we continue to work as a team like we have in the past we will continue to make Swan Hill a great place to live and work.

So thank you for that every one and all the best.

One last thing, the most important person I forgot to mention, my wife. I did mention her in the paper. When I wrote the last mayoral column it was quite interesting, my wife said you don't have to mention me and I said "Yes, I do". The support that she has given me over the term as mayor and it's now time to spend a little more time with her. And as I told the media department girls when they also said you don't have to mention me I said "Yes, I do", because it's not just about one person, one person is not Council and one person will never be Council. I think it's important to remember all the work that's done by everyone around this table and everyone back at the office and the depot, they are the ones that make us look good and we should never forget that. We should never forget the people that have moved on such as the Directors that have done projects and had input into where we are today. Hopefully

we will have a lot of input into where we go into the future, so other councils in the future may be able to say thank you for your contribution as well.

Summary

Council need to determine whether the Mayoral term is for one year or two years.

Discussion

In accordance with Local Government Act 1989 Section 71, Council must:

- 1. At a meeting of the Council that is open to the public, the Councillors must elect a Councillor to be the Mayor of the Council.
- 2. Before a Mayor is elected under this section, the Council may resolve to elect a Mayor for a term of 2 years.
- 3. The Mayor is to be elected
 - a. After the fourth Saturday in October but not later than 30 November in each year; or
 - b. If under subsection (2), the Mayor is elected for a term of 2 years, the next election of Mayor is 2 years after the fourth Saturday in October but not later than 30 November in the second year after the election; or
 - c. As soon as possible after any vacancy in the office of the Mayor occurs.

Financial Implications

Costs associated with Mayoral allowances and ancillary costs are included in the budget each year.

Currently the Mayoral allowance is \$64,939.33 p.a. plus equivalent superannuation (allowed range up to \$78,051 p.a.). The Councillor allowance is \$24,447.13 p.a. plus equivalent superannuation (allowed range \$10,490 to \$25,225 p.a.). These

allowances are adjusted annually by the Minister for Local Government. The Minister has announced the allowance will increase by 2% from 1 December 2018.

Summary

This report outlines the process and statutory requirements for the election of Mayor. The election of the Mayor will take place as part of this report.

Election of Mayor

The Chief Executive Officer must conduct the election of the Mayor in accordance with the Local Government Act and Council's Local Law Number 1.

Discussion

Under section 71 of the Local Government Act 1989, the Councillors must elect a Councillor to be the Mayor of the Council.

Section 73 of the Local Government Act 1989 states that the Mayor of a Council takes precedence at all municipal proceedings within the municipal district and that the Mayor must take the chair at all meetings of the Council at which he or she is present.

The Mayor should lead the Council in relation to policy making and the setting of Council priorities.

The role of the Mayor is to:

- Chair Council meetings.
- Exercise the casting vote at Council meetings when required.
- Represent the municipality at ceremonial occasions and in political forums.
- Lead, coordinate and provide guidance for the Council and Councillors.
- Lead the Council in relation to policy making and the setting of Council priorities.
- Speak publicly about the Local Government's role and developments in the community.
- Oversee the performance of the Chief Executive Officer
- Liaise closely with the Chief Executive Officer to ensure effective relationships between Council and its administration in pursuing Council goals.

Prior to the election of the Mayor it is customary to allow the outgoing Mayor the opportunity to speak of their time in the role.

The process to Elect a Mayor will be:

- 1. The CEO will call for nominations for the position of Mayor.
- 2. If only one nomination is received and the nominee is willing to serve as Mayor, the nominee will be declared elected.
- 3. If more than one nomination is received, each nominee will be allowed up to 5 minutes to speak on their own behalf. An election will then be held.
- 4. The election will be by show of hands. If there are two nominees the person with the most votes will be declared as Mayor. If there are more than two nominees the person with the least votes will be removed as a nominee and similar rounds of voting will occur until a Mayor is elected. Any tied votes will be determined by ballot.

I think Swan Hill is definitely on a upward trend and having been born, grown up and educated (both primary secondary and tertiary qualifications in Swan Hill) I think it's a great place to live and I'm really looking forward to this time and we have a good future in front of us. Summary

The Local Government Act 1989 does not require Council to have a Deputy Mayor, however Council has previously resolved to have a Deputy to support the Mayor and Council.

Discussion

Council adopted a Deputy Mayor Position Policy (**POL/GOV006**) to support the position of Mayor and the operations of the Council in September 1999. This policy was last reviewed in May 2015.

The position of Deputy Mayor is necessary to facilitate the smooth and uninterrupted civic, statutory and policy-making functions of Council in the absence of the Mayor.

Swan Hill Rural City Council Local Law No 1 "Meeting Procedures Local Law", Part B stipulates that the procedure for the election of Deputy Mayor shall be the same as that for the Mayor.

Section 73 of the Act provides that:

- If there is a vacancy in the office of Mayor or the Mayor is absent, incapable of acting or refusing to act, the Council must appoint one of the Councillors to be the acting Mayor.
- An acting Mayor may perform any function or exercise any power conferred on the Mayor.

It would be appropriate for the Deputy Mayor to act as Acting Mayor for the purposes of Section 73, however Council may appoint any Councillor to be Acting Mayor.

The election of the Deputy Mayor will follow the same process as the election of the Mayor except that the Mayor will conduct the election.

Financial Implications

There is no provision in the Act for a separate allowance for Deputy Mayor.
