### Summary

The purpose of this report is to enable Council to receive and hear submissions in relation to the proposal to sell 71-77 Bromley Road Robinvale.

At the close of the public notification period 99 submissions were received. In addition a petition of 499 signatures has been submitted and will be received by Council at a different stage of this special meeting

#### **Discussion**

At its Ordinary Meeting on Tuesday, 22 January 2019, Council resolved to give notice of its intention to sell two properties in Bromley Road Robinvale. Council owns these parcels of land and purchased them for strategic purposes to ensure it has control on any future use.

In 2018 Council was asked if it would consider selling these properties to allow for a commercial development. Following targeted consultation with some key community groups in Robinvale, Council resolved to pursue the sale of the land by commencing the process as required under the Local Government Act (the act).

The Act requires Council to give notice of its intent to sell land and allow submissions to be made. The public notice advertised in local newspapers detailed that anyone requesting to be heard in support of their submission can appear before a meeting of Council or be represented by a person acting on their behalf.

A total of 99 written submissions were received consisting of:

- 20 submissions that support the sale of the land
- 79 submissions that object to the sale of the land

Nine submitters have requested to be heard and this meeting provides that opportunity.
