Having given due notice, **Councillor Nicole McKay MOVED:**

That Council receive a report at the February Council meeting identifying how the total revenue generated by the sale of land at 71 and 77 Bromley Road, Robinvale could be used for the protection of heritage, or the enhancement of heritage precincts in Robinvale.

Preamble

The Swan Hill Rural City Council has voted in favour of selling land at 71 and 77 Bromley Road in 2019, and at the December 2020 Council meeting voted in favour of issuing a planning permit for the development of a convenience outlet on the site.

The site is in the vicinity of the Visitor Information Centre, the Museum of Rural Life and the Robinvale Euston Regional War Memorial Park.

Swan Hill Rural City Council supports the preservation and showcasing heritage in Robinvale. The Council respects and recognises the commitment and substantial contribution made by the Robinvale community to the preservation of heritage and recognition of the sacrifice made by soldiers and community in war.

By reserving funds generated by the sale of land at Bromley Road for the preservation of heritage values in Robinvale, Swan Hill Rural City can affirm this commitment and respect.
