Summary

This report seeks to inform and obtain approval from Council on the use of surplus funding associated with Local Roads and Community Infrastructure Fund Round 1. The value of this surplus budget is \$83,830.

Discussion

In 2021 Council received funding of \$1.43M under Local Roads Community Infrastructure Fund (LRCIF) Round 1 to implement 17 projects throughout the municipality. These project and proposed budgets are listed below.

As of 1 April 2022, all of these projects have been completed, with a surplus of \$83,830 remaining. As per the funding agreement, excess funding can only be allocated to nominated and agreed projects and must be fully acquitted by 30 June 2022.

To achieve this requirement and fully acquit LRCIF round 1, the following options have been listed for further consideration.

- Nyah West Footpath Construction of a dedicated 600m concrete path (1.5m wide) on the southern side of Monash Avenue. The required works to undertake this project have indicated it will be above set budget and allocated timeframe re: Request for Quote costing at \$215,000
- Robinvale Footpath A dedicated 1.5m concrete path approximately 400m length along Watkins Street (eastern side). The required works to undertake the project has not been tested by the market, therefore there is high uncertainty the project (or even part of the project) can be completed within set budget and timeframe.
- Lighting Treatment (Public Lighting) Tower Hill (Barry Steggall Park) lighting project. Required works for Tower Hill pedestrian lighting have been included in tender submission for the McCallum Street pedestrian lighting project, at a total cost of \$71,500. These works can be completed by 30 June 2022 and will complement the proposed lighting treatment for the McCallum Street path and lighting project.

Consultation

The Nyah West Footpath project has been highlighted by the Nyah Action Group as a key priority project for their township.

Community feedback from the McCallum Street path and lighting project included the need to continue the lighting treatment into Tower Hill estate.
