
#### Summary

On 20 September 2022, Council resolved to seek community feedback on the naming of the main east-west arterial road through the Southwest Development "Laura Kirby Boulevard". This report is presented to Council to consider the submissions received.

#### Discussion

At the 20 September 2022 Council Meeting the name "Laura Kirby" was selected from the Draft Asset Naming Master List for the naming of the main east-west arterial road through the Southview Development as shown in grey below:





The proposal was advertised within the local papers, through social media and on Council's webpage through "Let's Talk." As the proposal also represented a prominent First Nations woman, the local First Nation community and the Kirby Family were consulted through Council's Aboriginal Community Development Officer.

There was one objection received (attachment 1). This objection was from the Developers of Southwest Development Precinct and indicated a preference for naming the road something simple and easy to remember rather than a past citizen. The objection argued that there are many notable and deserving past citizens. The objection has requested that the name "Sunrise Way" or "Sunrise Boulevard" be considered as an alternate name and have also put forward that they would be willing to consider naming a park on their development after Laura Kirby in lieu of the road name. The Developers may consider a design collaboration with the First Nation community but would prefer to have final say to ensure that any park is consistent with the theme of their development.

There were five submissions in favour of the proposal received through "Let's Talk" (refer to attachment 2). The submissions honoured the contribution that Laura Kirby has made to the community,

Council's Aboriginal Community Development Officer had held two community meetings with First Nation groups as well as many informal discussions with the community which indicate excitement for honouring Laura Kirby through asset naming. Informal discussions also indicated that a park could be discussed particularly if the First Nation community could help with designing the space and plant some memorial trees.

As an objection has been received, the Asset Naming Officer sort further guidance from Geographic Names Victoria (GNV). The following advice was received:



- It is not a formal requirement of GNV for road names on Plan of Subdivisions to go through Council Approval. This requirement is a Council policy to ensure that Council, as the road naming authority, has oversight in naming of roads.
- The statutory requirements for naming roads, features and localities, *Naming rules for places in Victoria 2022,* states that a commemorative name applied to a locality or road may use the last name <u>or</u> the first name of a person; although it is preferred that only the last name be used. Whereas a commemorative name applied to a feature can use the first name and last name of a person; although it is preferred that only one name be used. GNV, who have final approval on the name, indicate that their preference would be for either "Laura Boulevard" or "Kirby Boulevard" in keeping with the naming rules.
- If an asset name is non-commemorative, the road name does not need to go through a public submission process.

Given this advice and support to recognise Laura Kirby through the naming of a park or reserve, the following options were then considered:

- Name a green space within the Southwest Development as offered by the developers.
- Rename an existing park within Swan Hill that does not have a commemorative name.
- Formally name an unnamed reserve.
- Apportion off and rename the bush tucker garden section within the northeast of Barry Steggall Park.
- Reserve the name "Laura Kirby" for future use for parkland in Council managed Developments. Potential options include;
  - Stage 15 public open space
  - Stage 21 Northern Park off Woorinen Road.

Preliminary feedback from Councils Aboriginal Community Development Officer favours the apportioning of the bush tucker garden in Barry Steggall Park to create a reflective space that allows opportunity to recognise individual First Nation people through potential artwork (eg sculpture) and landscape design. It is proposed that the park be named using local language that embraces all community while offering a space to acknowledge the contribution of the Kirby family, including Aunty Laura and Aunty Esther, as well as other First Nation families from the region.

Further consultation with the First Nation community regarding the naming will be required.

This report to Council for decision was delayed allowing time for Sorry Business after the passing of Laura Kirby's daughter, Aunty Esther in late October 2022.



#### Consultation

*Naming rules for places in Victoria 2022* specifies that any person or organisation can lodge a submission in objection or in support of a naming proposal. The submission period must be at least 30 days.

The naming proposal was advertised within the local papers, through social media and on Council's webpage through "Let's Talk." As the proposal also represented a prominent First Nations woman, the local First Nations community and the Kirby Family were consulted through Council's Aboriginal Community Development Officer.

After the Council resolution, discussions were held regarding an objection from the Southview developer on behalf of all the developers. The developers were not sent a formal invite to make a submission.

As Council has engaged the community with regards to the proposal to name the road, there will be no further community consultation required.

Preliminary consultation has been held with Councils Aboriginal Community Development Officer for suggestions and to ensure that the recommendations being considered by Council were appropriate and respectful to the First Nations people.

If Council resolves to proceed to name a park or reserve, it will be a requirement that the First Nation community and the family of Laura Kirby be further consulted for approval as well as any immediate neighbours or users of the park.

Any costs associated with the initial delivery of this project can be borne from existing Council Budgets.

Asset Naming can present Council with an opportunity to recognise prominent locals as well as provide connection to country or place.

#### That Council:

- 1. Consider all submissions and objections and formally name the east-west arterial road through the Southwest Development "Laura Kirby Boulevard" and seek an exemption from Geographic Names Victoria to use first and last names in a road name.
- 2. Consider all submissions and objections and formally name the east-west arterial road through the Southwest Development road "Laura Boulevard" or "Kirby Boulevard".
- 3. Formally name the east-west arterial road through the Southwest Development "Sunrise Boulevard".
- 4. Undertake consultation with the family of Laura Kirby and the First Nation community to apportion a section of suitable open space (eg bush tucker garden in Barry Steggall Park) to create a reflective space and to name accordingly.

Mr Mayor & Councillors,

#### **RE: Collector Road Naming – SWDP**

We refer to the recent controversy surrounding the proposed naming of the Collector Road running through the South West Development Precinct and wish to formalise our collective objection to Council's action in not consulting with us on a matter of great significance to us, given our commitment to invest in the order of \$100million in our respective developments.

This is a significant road in Swan Hill that will serve as the main road for over 600 housing lots. It extends for approximately 2.5 Km through our properties from Sea Lake Road to Yana Street. The approved Master Plan for the SWDP shows the road extending from Sea Lake Road to Coronation Avenue, providing a major new east west link through the town.

We are extremely disappointed that, as the people who are paying <u>ALL</u> the costs for this road, we have not been consulted about the name.

Based on recent local road costs, and verified by Heil Engineering, our combined costs for provision of this road are well over \$15million. There is <u>NO</u> Council (ratepayer) contribution towards the cost of this road and of course there is a further significant cost to developers of the land sacrificed to build the road.

It can be argued that numerous past Citizens of the area are deserving of having a road named after them. Arguments for and against the relative

importance or significance of various past citizens has the potential to be divisive.

Our preference is for a simple, easily remembered, aspirational name, not that of a deceased person.

Councillors would be aware that the property owned by Piranox and Oasis Swan Hill Trust will include a number of significant parks. The owners of that land are happy to consider naming a park on their development after Laura Kirby.

We would like to put forward the name Sunrise Way or Sunrise Boulevard as the name for this new road.

It is:

- a. Simple
- b. Easily remembered
- c. Aspirational (new day, new beginning)
- d. Culturally neutral. Sunrise is a significant feature in many of the myriad of cultures that make up our local population including First Nations people\*

\* The Sun is a centre point of Aboriginal and Torres Strait Islander cultures across Australia. Featured on the Aboriginal flag, the Sun is the source of life and death, bringing life and heat to the people. In many Aboriginal traditions, the Sun is a woman, and the Moon is a man.

Aboriginal and Torres Strait Islander people marked the rising and setting position of the Sun throughout the year, noting important times that coincide with the solstices and equinoxes. This was accomplished by observing the Sun's position using landscape features or human-crafted features, such as stone arrangements. Wurdi Youang is a famous example, but others abound.

\*From Australian Indigenous Astronomy website. (Supported by The University of Melbourne)

It is our consolidated view that this suggested name is the most appropriate, and its adoption would be reflective of a consultative process and a means of finding consensus on naming an asset that is being totally funded by private interests. It is not unreasonable for us, as owners of the land, to have substantial input into naming the asset, provided it does not offend, is not partisan and delivers a positive, uplifting message.

We respectfully submit that this would be a just, fair and agreeable outcome to an otherwise potentially divisive action by Council.


