#### **Summary**

The purpose of this report is to share feedback provided by the community, via the Mayor and Member for Mildura, Jade Benham, regarding the recent decision to authorise travel for the Mayor to visit Yamagata, Japan and not authorise travel to Villers-Bretonneux, France in April 2024.

#### **Discussion**

At the Scheduled Meeting in December 2023 (full report attached), Council considered two invitations received by the Mayor to visit Yamagata and Villers-Bretonneux in April 2024, the following motion was put and carried:

#### **That Council:**

- 1. Formally thank the Mayor of Yamagata for the invitation to Swan Hill Rural City Council's Mayor;
- 2. Authorise the Mayor to accept the invitation to visit Yamagata in 2024.

The Mayor has received community feedback, along with an email via the CEO and cited an accompanying letter to the editor of the Sunraysia Daily from Jade Benham, Member for Mildura.

The Mayor has advised of general community concern including feedback from residents after this decision, expressing concerns regarding Council's decision for the Mayor not to accept the invitation to attend the 40th Anniversary of the sister city relationship between Robinvale and Villers-Bretonneux.

Council may unintentionally offend one of our sister city relationships with the contradiction of accepting an invitation from Yamagata, while rejecting the invitation from Villers-Bretonneux.

According to Jade Benham, the decision has raised concerns within the Robinvale community, particularly given the special significance of this year being both the 40th anniversary of our sister city relationship during Robinvale's centenary year.

Council has been asked by the community to reconsider this decision made in December 2023, for equal consideration of both sister cities.

New information to be considered by Council is that from 2003 to 2023, Council records show that representatives have officially visited Yamagata five times and Villers-Bretonneux once.

Acknowledging the importance of maintaining both sister city relationships and continuing the great work that the Council has accomplished over the past 40 plus



years, officers are recommending an amendment to the December 2023 motion be made.

It should also be noted that previous Council representatives have more frequently visited Yamagata than Villers-Bretonneux.

Council risks offending volunteers associated with either sister city arrangement when we accept one and not the other.

#### **Summary**

The purpose of this report is to provide details of invitations to the Mayor Cr King to visit Yamagata and Villers-Bretonneux in April 2024 to celebrate the relationship of the sister cities.

#### **Discussion**

Sister city and twin town relationships give Council and our community new economic and education opportunities. It also expands our international communication, cultural awareness and co-operation.

Council has strong ties with its international partners, including cultural, education, economic and historic links.

The relationship between Swan Hill and Yamagata officially started in 1980. It was one of the earliest Sister City arrangements with Japan.

Villers-Bretonneux was adopted as the twin city of Robinvale in 1984-1985. However the first visits were made in late 1970s including a youth exchange.

The 40 plus years of association with Yamagata and Villers-Bretonneux has provided many opportunities for students and community members to build long and lasting friendships.

#### LETTER TO THE EDITOR

Dear Editor,

I am writing to express my deep disappointment regarding the recent decision made by the Swan Hill Rural City Councillors on December 19, 2023, to decline an invitation for the Mayor to attend the 40th Anniversary of the Sister City relationship with Robinvale and Villers Bretonneux.

This decision has not only disheartened me personally but has also left the Robinvale community, especially the dedicated Villers Bretonneux Association, feeling let down. What makes this decision particularly disheartening is the fact that the invitation and the subsequent trip were to incur no cost to the Council and ratepayers.

The Villers Bretonneux Association, a volunteer organization, has consistently demonstrated remarkable dedication in fostering an incredibly close and connected relationship with our sister city since its inception. Their efforts contribute significantly to the cultural exchange and mutual understanding between our communities.

The decision to accept the invitation from Swan Hill's sister city, Yamagata, while rejecting the invitation from Villers Bretonneux, seems contradictory to the commitment the Council has made in servicing Robinvale as a major centre rather than a small service town. This decision threatens to undermine some of the commendable work the Council has accomplished over the past four years.

In a significant year, when we celebrate not only the 40th anniversary of our sister city relationship but also Robinvale's centenary year, choosing to favour one sister city over another feels akin to choosing a favourite child. I believe such a decision sends the wrong message and risks eroding the strong bonds that have been cultivated over decades.

I strongly urge the Councillors to reconsider this decision and avoid showing favouritism towards one sister city over another. I hope the Councillors can honour the sentiment this brings, and I trust that they will reconsider their decision in the best interest of our community.

I hope to see a positive resolution for the sake of our Sister City relationships and the Robinvale community.
