

Did You Know?

Labour Government reforms showing widespread backing for key proposals that will further strengthen animal welfare provisions. Public and industry feedback is currently being sought on key proposals for a new Act to replace the *Prevention of Cruelty to Animals Act 1986* (the POCTA Act). The proposals aim to improve existing provisions under the POCTA Act and support Victoria's reputation for high standards of animal welfare. If the draft Bill is passed by the Victorian Parliament to become an Act, the new Animal Care and Protection Act would replace the current Prevention of Cruelty to Animals Act 1986 (the POCTA Act) after more than 30 years. Animal sentience will be recognised for the first time in Victoria's animal welfare laws.
